Your account must be created by 2/26/19. PLEASE email Prof. Marwick for help.

You will need:

- A bank account.
 - If you do not have one, please email Professor Marwick immediately for alternate directions.
 - O Your routing number: 9-digit bank code, which appears on the bottom of your check as first set of numbers.
 - O Your account number: on the bottom of your checks as a second set of numbers.
 - o If you do not know these numbers, you can log into your online bank account and find them there.




NOTE: You almost certainly will not make any money from this assignment. However, you must complete this information accurately.

Steps: Please read carefully!

- 1. Go to https://kdp.amazon.com/en US/
- 2. Sign in, either using your own Amazon account or creating a new KDP account. For this exercise, I recommend you create your *own Amazon account* that is not your parents' account. You will not have to buy anything or spend any money.
- 3. In the Author/Publisher information, fill in your name, address, and phone number (see screenshot on next page). This can be your home address or school address.
- 4. In the "Getting Paid" section, add your account number, routing number, and name of bank (Bank of America, Wells Fargo, BB&T, etc.). Click "Add". If you have a Japanese, Brazilian, or EU bank account, you can also fill in this info. Let me know if you have trouble.

5. Click on "Complete Tax Information." This will take you to another screen. The **Tax Interview** may look scary, but it is basic information that as you go into the working world you will be filling out many times.

Who will receive income from Amazon or its subsidiary? Individual

US Person? Choose "**US Person**" (citizen) or a "**Non-US Person**" (green card holder, exchange student, citizen of any other country except the US).

Federal tax classification: choose Individual/sole proprietor.

Name: your legal first and last name (no nicknames)

Address: your permanent address, probably your family's house

Tax Identification: your Social Security number, ITIN, or EIN.
